- 2. All BDOs are the head of their respective Block Level Committees and Officer-in-Charge of Camps conducted in ADCC Constituencies falling under their respective jurisdiction and are responsible for identification of suitable venue, allocation of space for participating departments and overall organization of the camps. They shall communicate the location/venue of the camps well in advance to all the stake holders via notification and ensure adequate publicity of the camps and maximum public participation.
- 3. On conclusion of each camp, they shall submit their report, along with photographs, in the prescribed format which is inclusive of fields, among others, like Scheme, Enrolled/Identified, Delivered, Rejected Pending, Target Date and Remarks. If required, other details of services provided shall also be included in the report.
- 4. All the DLOs will make their own arrangement for requisite logistics such as furniture, IT equipments, stationery, banners displaying services provided under their respective departments and other contingencies for their stalls and counters. They shall also ensure active participation of their nominated BLC members in the Go to Village Camps.
- 5. All DLOs in coordination with their nominated BLC shall prepare a list of deliverables well before the commencement of each camp and inform the beneficiaries and their respective Head of BLCs accordingly.
